## Stallion Service Contract

and expenses. Of this amount, a non-refundable booking fee of \$ \_\_\_\_\_ is payable upon execution of this contract,  
and the balance, plus all unpaid board and expenses will be paid by certified check, cashiers check, money order, cash or  
bank draft before my mare is picked up, whether my mare is settled or not.

2. Board fee to be \$ \_\_\_\_\_ per day dry; \$ \_\_\_\_\_ per day wet.

3. You agree to try diligently to settle my mare up to and including July 1, \_\_\_\_\_, unless otherwise arranged at the  
time of signing of this contract.

4. If your stallion should die or become unfit for service, your obligations hereunder shall cease and any portion of a  
breeding fee provided for by this contract and heretofore paid by me, shall be refunded to me, if such event occurs prior to  
the time my mare is settled.

5. You agree to care for my mare and/or foal in a diligent manner and **Primrose Ranch** or its employees will not be  
responsible for any disease, accident, sickness or death of my mare or foal; you may exercise your judgment in caring and  
supervising for them or either of them and have a veterinarian perform, at your absolute discretion, veterinary services as you  
deem necessary or appropriate, at my expense. These services include, but are not limited to: worming, treating for  
infections, disease, shoeing, hoof trimming, accident or accident related conditions, preventative measures, original  
examination and pregnancy checking. I will likewise not be responsible for any disease, accident, sickness or death to your  
stallion or mares.

6. If my mare does not settle or fails to produce a live foal (a live foal is defined as one that stands and nurses after foaling),  
I will be entitled to return privileges the next applicable season to the same mare (unless otherwise mutually agreed). This  
privilege to re-breed is subject to the condition that I notify you of the death of the foal within one week thereof in writing;  
such notice must be accompanied by a signed statement from a licensed veterinarian stating the date of death of such foal,  
and stating that such foal did not stand and nurse.

7. You will issue a breeders certificate immediately upon request when all of the conditions of this contract are met, and the  
foal is alive and nursing.

8. A photo static copy of the mares registration certificate shall be furnished to you prior to breeding, and you are not  
obligated to breed said mare until such document is furnished to you. In the event that my mare is leased, I agree to furnish  
you and the appropriate association (APHA, AQHA, NCHA) an exact copy of said lease agreement, signed by me and the  
current owner of described mare.

9. When **Primrose Ranch**, by its authorized representative, signs and returns one copy of this contract to me, it will be a  
binding contract on both parties. This contract is not transferable or assignable.
